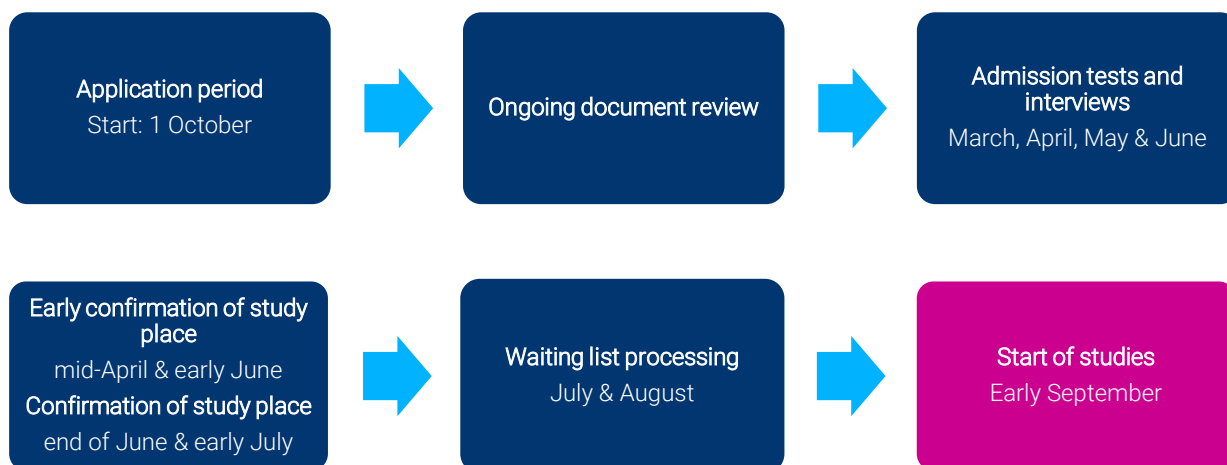

## 2. Application deadlines

The application portal is open for you from **1 October**.

## 3. Registration on the application portal

### ⚠ TO DO

After registering on our [application portal](#) you will receive your personal **access code by email**. Remember to check your spam folder if you have not received your access details immediately.

## 4. Deposit

If you have met your **admission requirements** in a **non-EU or non-EEA country** and if you are a **third-country national**, you will be charged a deposit of EUR 200,- during the submission of your application. This deposit will count towards your tuition fee for the first semester if you are admitted to one of our degree programmes. If you decide not to study at UAS BFI Vienna, we will refund your deposit after the admission procedure is completed in autumn (in November). For more information, please refer to our [general terms and conditions](#).

Please note that the payment must be received in our bank account **before the application deadline, otherwise your application cannot be considered**. If you transfer the deposit using a payment method other than a credit card, this may take a few days.

## 5. Application for your desired degree programme

### TO DO

Use your access data to log in to the [application portal](#) again. Now you can select your desired degree programme – several are also possible. Please complete all fields and upload the required documents. All mandatory documents are marked in red. If documents relevant for admission are still missing at the time of application (e.g. your bachelor or diploma certificate), then upload your last available educational document (e.g. current transcript of records). Please indicate in your CV when you expect to receive the access-relevant certificate and submit it via the application portal as soon as you receive it.

### Required documents for applications to master programmes:

- ✓ Passport photo
- ✓ Passport
- ✓ Secondary school leaving certificate <sup>1</sup> or university entrance qualification exam <sup>1</sup> or subject-relevant apprenticeship diploma plus certificate of a vocational school <sup>1</sup> or graduation from a school for intermediate vocational education (BMS) <sup>1</sup>
- ✓ Bachelor or diploma certificate <sup>1</sup>
- ✓ Transcript of records <sup>1</sup>

Once you have completed all the data on the application portal and uploaded your documents, please submit your application. This step must be done separately for each degree programme you have chosen in the **menu item "Overview"**.

## 5.1 Application status

Check your application status in the application portal under the **menu item "Overview"**:

**Application received:** Your application has been sent successfully.

**Application being processed:** Your application will be processed by our staff. The processing time may vary depending on completeness of your documents and the volume of applications we receive.

**Admitted to the admission test (Appointment booking from March):** If you submitted your application between **October and February**, it is (provisionally) complete, and you meet the admission requirements, or we have informed you that additional documents are required (e.g. completion of your studies is pending). You will receive further information on the admission test by email from **March** onwards.

**Admitted to the admission test:** If you submitted your application between **March and May**, and it is (provisionally) complete, you meet the admission requirements or we have informed you that additional documents are required (e.g. completion of your studies is pending). You will receive further information on the admission test from us shortly

**Admission test completed:** You have taken the admission test and have been included in our ranking for study place allocation.

**Study place confirmation:** We will confirm your study place by email. As soon as the education contract is sent to you ([see chapter 9](#)), your status on the application portal changes to "Study place confirmation".

## 5.2 Applicants with foreign documents and international degrees

Please have any documents not issued in German or English translated into one of these two languages by an **authorized translator** and upload the translation to the application portal together with the original document. Depending on the country, where your documents were issued, different legalizations may be required. [The Legalization List for Higher Education](#) of The Austrian Federal Ministry of Education, Science and Research provides detailed information on of the required legalization for your documents.

For specific admission requirements related to foreign school leaving or degree certificates, or international certificates, please contact our [Admission Office](#). We will inform, if supplementary exams are required. Supplementary exams must be taken in addition to the admission test before the start of the degree programme at UAS BFI Vienna. For more information, please refer to our [general terms and conditions](#).

### Required language level

For our degree programmes offered in German, you require German language skills at [CEFR-level C1](#) and English language skills at level **B2**.

For the degree programmes offered in English you require English language skills at [CEFR-level C1](#). German language skills are not required.

Your language skills will be assessed during the admission test. If necessary, supplementary exams in German or English may be prescribed.

## 5.3 Bridging courses

If you generally meet the admission requirements but lack **a few ECTS credits** you can make up for these in selected [bridging courses](#). If this applies, the degree programme ECTS coordinator will invite you to register for one or more bridging courses.

## 5.4 Applicants with special needs

A barrier-free access to the institution and our degree programmes is very important for us. If you want us to accommodate your special needs during your admission procedure, please remember to contact our Gender and Diversity Officer [Marion Roßhap](#) in time before your admission test.

# 6. Your master programme admission procedure

The admission procedure for master programmes consists of an online admission test followed by an oral part, which may be an interview, presentation or in another suitable format.

## 6.1 Choosing your admission test date

### TO DO

As soon as we have checked your application and you meet the admission requirements, we will invite you to the admission test. Your status under the **menu item "Overview"** will change to **"Admitted to the admission test"** for the respective degree programme(s). The test takes place on several dates in the summer semester. From March onwards, we will inform you by email that you can now book your test date **yourself** within seven days.

**Please note:** This deadline may be shortened if you have only applied by the end of the application period!

Again, you can book your test date via the application portal under the **menu item "Admission test"**, where you can also see your booked date (for each degree programme).

In order to book an appointment for the admission test, you must first provide information on the educational qualifications of your parents or caregivers in a parental role under the **menu item "Personal data"** on the application portal. This information will be sent to Statistics Austria. UAS BFI Vienna is legally obliged to collect this data from its applicants for the Federal Ministry of Education, Science and Research before they take the admission test and to forward it accordingly.

Cancellation or change of test date is not possible. Please contact our info point at [info@fh-vie.ac.at](mailto:info@fh-vie.ac.at) or +43 1 720 12 86 in good time if you have to postpone an already fixed date for urgent reasons.

If you have not booked a date for the admission test within the specified period, we regret that we will not be able to consider your application any further and you will be excluded from the admission procedure.

## 6.2 Access details for your admission test and your sample test

### TO DO

Within **24 hours** of booking your appointment for the admission test, you will find your access data for the online test portal in a green box under the **menu item "Admission test"** on the application portal. You can use these to log in at any time and take a sample test. This serves to check the technical functionality, does not reflect any questions from the admission test and will not count towards its result. We highly recommend that you complete the sample test.

All information regarding the technical requirements for both the sample and admission test can be found [here](#). You will need a **laptop or PC with a camera and microphone** (tablets or mobile phones are not suitable) and the **Chrome browser**. ## 6.3 How to prepare for your admission test

### TO DO

For optimal preparation, you will find **individual preparation material** for the admission test in each of our master programmes on our website from the end of January. A course from external providers is not required.

Once you have taken the test, you will be informed by the degree programme about **time, duration, content** and **format** of the second (oral) part of the admission test. The online admission test is assessed at **60%**, the oral part at **40%**.

## 6.4 Taking the admission test

### TO DO

On the day you choose for the admission test, you will have **24 hours** to complete all parts of the test, starting at **00:00** and ending at **23:59 (local time Vienna)**. This gives you maximum flexibility to take the test with as little stress as possible. If your test comprises several sections, you can take a break between individual test sections. Once a test section has been started, you can no longer interrupt it. Please ensure that the camera of your laptop or PC is turned on during the test and that you are clearly visible and recognizable.

Please note that we can only rank you for a study place if you have completed all the required test sections. Should you have any **technical problems** during the admission test, IT support is available from **8:00 to 20:00 (local time Vienna)** at [support@e-learning-consulting.com](mailto:support@e-learning-consulting.com) or +43 1 361 97 67 17. In your own interest, please report all technical problems to IT support immediately.

All applicants who have taken the written test will then be invited to the oral part.



## 6.5 Admission interview

After the admission test, the oral part takes place as an **interview**, a **presentation** or in **another suitable format**. You will receive all details and requirements in timely manner. The total number of points achieved in both test parts determine your place in the ranking list for a study place.

After both parts of the admission test have been evaluated, your status on the application portal will change to **"Admission test completed"**.

## 7. (Online) info sessions

### TO DO

Each degree programme offers (online) info sessions on several dates throughout the year. You can find the dates on our [website](#) by navigating to the degree programme(s) you are interested in.

Here you have the opportunity to learn about **content**, **structure** and **career prospects** of the degree programme with those responsible for it and to find out whether it is the right degree programme for you. Please take advantage of this chance to get to know the degree programme and its team, and to clarify any questions you may have.

## 8. Study place information or place on the waiting list

We inform our best applicants at an early stage that we would like to offer them a place on the degree programme (**mid-April or early June**). Even if you do not receive a study place confirmation, you still have a chance to study at UAS BFI Vienna: The final ranking will be made at the **end of June/beginning of July** and all applicants will be informed by email about their admission or a place on the waiting list at the latest. Please give us quick feedback if you accept an offered place or if we can pass it on to other applicants on the waiting list.

## 9. Your education contract

### TO DO

Your education contract including all attachments as well as information on transferring the tuition fee and the Austrian Students Union fee ("ÖH-Beitrag", [see chapter 10](#)) will be emailed to you a few days after your study place confirmation. Your status on the application portal will change to **"Study place confirmation"**. After signing your education contract, please scan it in its entirety and upload it via a link provided by us. Your place is confirmed when the signed education contract has been uploaded and the tuition fee has been transferred by the deadline. You have **14 days** to do this.



## 10. Tuition fee and Austrian Students Union fee

The tuition fee amounts to **EUR 363.36** per semester and the Austrian Students Union fee ("ÖH-Beitrag") to **EUR 24.70** per semester. This applies to Austrian as well as to international students. Participation in the admission procedure incurs no fees. If you have been prescribed one or more supplementary exams as part of the admission process, the examination fee must be paid prior to taking the exam(s). ## 11. Starting your studies

You will receive all details regarding **enrolment, student account** and the **first semester** (start of studies, timetable etc.) from your programme coordinator in good time before the start of studies via email. The winter semester starts in **early September** for master programmes.

You must bring and present your **original admission certificates** (certificates, e.g. bachelor certificate or diploma supplement) to your first administration meeting. You will also receive your **student ID card** here. International certificates must be presented to Admission Office. You will be contacted regarding this via email during the summer.
